Notes :

- From the Membership Fee the Ithaca Creek Swim Club has to pay a Swimming Australia fee (\$17.60), a Swimming Queensland fee (\$19.40), a Brisbane Swimming Association fee (\$7.00) and associated insurance premiums. The club in most cases only gets approximately 40-45% of the fee paid and uses this for the running costs of the pool.
- Fees are to be calculated per family.
- To calculate multiple fees in one family, any Associate member will be considered as the last swimmer/s and charged at the lowest applicable fee.
- There is no pro-rata membership fee arrangement for swimmers who join the Club part way through the season. However a Winter Membership exists for those that join in the 2nd/3rd school terms.
